

Carolina Solis-Herrera, MD


Associate Professor/Clinical, Chief of Division of Endocrinology, Department of Medicine, Long School of Medicine

Kumar Sharma, MD, FAHA, FASN

L. David Hillis MD Endowed Distinguished Chair of Medicine, Chief of Division of Nephrology and Vice Chair for Research, Department of Medicine, Long School of Medicine

As Distinguished Chair of Medicine in the Division of Nephrology, Vice Chair for Research and Director of the Center for Renal Precision Medicine, Dr. Sharma is best known for his seminal work on the pathophysiology of diabetic kidney disease, the most common cause of end-stage kidney failure around the world. He makes significant contributions to the literature, advances our understanding of the biological basis and potential treatment of kidney disease, gains an international reputation for his work, and promotes the research mission at UT Health San Antonio. Dr. Sharma has authored more than 210 peer-reviewed publications, and his work has more than 30,000 citations. He is well-funded by state and federal agencies - including the UT Stars, DOD, VA, NIH, NSF and NASA - and has received numerous awards and recognition, including invitations to serve on NIH, State of Texas and professional society advisory committees, bringing distinction to our institution. A strong advocate of team science, he plays leading roles in several large initiatives for kidney disease, such as the Chronic Renal Insufficiency Cohort, the Kidney Precision Medicine Project to understand individual factors driving kidney disease and the CKDBioCon consortium to discover new biomarkers for progressive kidney disease. His involvement in this breadth of research speaks to his collaborative nature and the esteem he holds within the scientific community. It also provides our junior faculty with added opportunities to participate in national research efforts.
